Neighbors privacy always trumps view.

"Every home in our neighborhood contributes to the overall impact of our community and determines the value of our homes When was the last time you stood in the street and looked at your property from lot line to lot line?"

Privacy, View, & Lighting—Trees

One thing we all covet is our privacy, view, & lighting policy. Whenever you make any alterations to your property it needs to be approved by the architectural committee for that very reason. With the drought and the bark beetle infestation we have lost a number of large trees.

We want to remind you of Rule 5.03 d. Cutting Trees. No trees over four inches in diameter at a point 4 feet above the base are to be cut on native ground without prior approval of the Board. A request to remove trees should be included on the application with photographs of existing trees.

If you severely trim or remove any trees without permission and affect your neighbors privacy you may be required to plant new mature trees to rectify the situation. It is always better to ask for permission rather than forgiveness!

Street Parking & Garages

3.05 Street Parking

The parking of cars on the street is considered to be an aesthetic problem as well as an obstruction to pedestrian and vehicular traffic, creating a safety concern for all. Lot Owners are required to arrange for off street parking for every vehicle regularly kept at the premises. The Street Committee shall investigate any vehicle reported to be street parked for more than three days and shall ascertain the Lot Owner's plans for its continuing disposition.

3.06 Garages

Garages shall be used primarily for parking of vehicles. Vehicles are to be inside garages, on Lot Owner's driveway, or within other housed or vegetation screened locations. Garage doors shall be kept closed, except as reasonably required for access.

Remodel/Landscape Construction

Alvarado Estates has had a lot of turnover in homes recently. In addition, many residents are remodeling, re landscaping or even building new homes in our community. All of the investment into these projects will increase the value of our neighborhood and keep it looking good into the future.

When any homeowner is planning a new project they need to first obtain approval from the Architectural Committee before work begins. In addition, the Architectural Committee has received complaints regarding contractors and their employees or other types of tradesman for various issues that have caused us to specify new <u>Project Requirements</u> for the homeowners and their workers to adhere to. We follow the same rules as the City.

As I write this, the City's plan is to finalize the project and put the streets surrounding us back in working order. What Side of the Road ...

Should I Walk On? According to California Vehicle Code Section 21956, pedestrians should walk on the left-hand edge of the roadway, which means facing oncoming traffic. This is intended to give the driver ample opportunity to see the walker and give the walker an opportunity to establish eye contact with the driver. When bicycling, the cyclist should ride on the right side of the road, going in the same direction as automobile traffic.

With no sidewalks and limited overhead lights in our neighborhood, it is important to think of safety first. Always carry a flashlight and/or wear reflective clothing when walking or cycling during dawn or dusk. And don't forget Fido! A reflective collar or leash can help him be spotted in dim light as well. Stay safe!

Pitch n' Putt—Preserve Your Park Legacy!


Thanks to the generous support of the community we are ready to break ground and install the putting green in late December, barring no more delays.


Jack and his wife Mary Margaret bought their property on Toyon Road in 1953 and built their dream home in 1956, where they raised their daughter and two sons.

Montezuma Trail & ...

Over the past couple of years, on these pages and at our board and annual meetings you have heard about the efforts initiated by some of your board members to enhance the College Area community as a whole; primarily the Montezuma Trail, a complete streets project to improve pedestrian, bicycle and mass transit usage on Montezuma Rd. There has been some resistance to fleshing-out the scope, details and cost, primarily because of the cost to do so, even though that is meager.

At this point, it might make sense to take a step back and look at the project as part of a larger project to also improve the efficiency of motor vehicle traffic along the same strip between Yerba Santa and Fairmount. After all, the smooth flow of all modes of transportation, from walking to driving is the ultimate goal. Add to that the aesthetic improvements planned with the Trail project and we have the "Gateway" entrance envisioned in the original plan.

Another project has surfaced that will only add to the gateway concept. That is the Montezuma Wall. It is a mural, designed by the Art Department at San Diego State to be placed on the south side of Montezuma Rd., between 54th St. and 55th St. These and other projects can be jumpstarted with funds from the dollar-per-ticket fund. As many of you know, the fund came to be as part of the settlement of a lawsuit between Alvarado Estates and San Diego State when Cox/Viejas Arena was

built. The fund, as detailed in that settlement and memorialized in the final memorandum of understanding is to be used for the benefit of the College Area, for "capital improvements or operating costs in support of capital improvements, as agreed by the parties." The parties are the CACC, the City of San Diego and San Diego State. Even though it was the impact of traffic from the arena that generated both the settlement and the dollar-per-ticket fund, the purpose and use of the fund was not. However, over the years, it has been limited to the mitigation of traffic impacts which means that many, worthwhile, and clearly acceptable and desirable projects, which fit both the letter and intent of the agreement, have not been funded. This is clearly not right and we are taking a closer look and reviewing options. Given that there is over \$600,000 in the fund, it could jumpstart a lot of endeavors and now that the City has surpluses, it might be easier to launch successful initiatives for worthy projects. We will keep you informed and ask for your support in the near future. There are some tremendous opportunities to help shape the look and feel of our area. The better it gets, the better Alvarado gets.
