As all of you know, given the topography of our community, we are in an especially high-risk area. You may have noticed that SDG&E has replaced some of their most vulnerable utility poles with steel poles. That tells us that we must be extra vigilant and take whatever steps are within our means to reduce the danger to our community. Your board has and is taking steps to strengthen our defenses.

Your Fire Safety Responsibility

Without intentionally sounding like a broken record, I encourage all residents with lots that interface with native vegetation areas to proactively maintain the 100 foot defensible space mandated by the city’s fire codes. Remember that the code requires that land, 100 feet from a structure be maintained according to guidelines established by the fire department. Those 100 feet are straight, horizontal feet from the structure, not along the terrain, which given the slopes along our perimeter, could result in only 50 feet being maintained. As an example, some of the properties at the end of Le Barron, if they trimmed the 100 feet, according to guidelines, would probably reach Montezuma Rd. This would also alleviate the homeless encampment problem that adds to our fire risk.

I get together for coffee with some great friends every week. At this morning’s coffee, one of my buddies mentioned that he downloaded an app that texts him on a random basis, several times a week with a simple message—“remember, you’re going to die.” At first it sounded rather morbid but he said he loved it because it reminds him to enjoy every minute as he lives it. That is an easy thing to forget, which is why he loves the app. The holiday season is almost upon us. Whatever holidays you celebrate, my hope is that you spend them joyously with family and friends and that the next year bring all of us many positive, enjoyable experiences, worth remembering.

Party Protocol & Noise Curfew

Everyone has parties and most of the time neighbors display common courtesy and common sense. An incident was reported last year over Halloween weekend where the noise level and street activity went on past 2:30 am and finally ended at 4:30. Not only is that rude it is against the Rules of Alvarado Estates and the City of San Diego. When it comes to noise this is the general rule, "In residential-only areas, a typical noise ordinance sets a "sound curfew," or period of reduced allowable noise, between 11 p.m. and 8 a.m. on weekdays, and midnight to 9 a.m. on weekends."

Party Protocol—Let your neighbors know ahead of time, give them a phone number they can call if there are any issues that may arise, and plan to schedule a gate attendant (as we don't want to give out codes) should it run past our regular time period. Contact Steve Neu if you need to schedule a gate attendant at gate@alvaradoestates.org
Owners could be subject to a fine if issues arise due to party's going past the curfew.

Recipes—One Pot Meals



Pescado Veracruzano
(Veracruz-Style Fish)

**Recipe from “The
Gourmet Mexican
Kitchen” by
Shannon Bard**

Makes 4 servings—This is one of our all time FAVORITE meals!

- 4 6-ounce white fish fillets (I use wild halibut)
- 2 teaspoons salt, divided use
- ½ cup lime juice, preferably freshly squeezed
- ¼ cup olive oil
- 1 small white onion, thinly sliced
- 4 garlic cloves, minced
- 6 Roma tomatoes, diced
- 2 cups green Manzanilla olives, halved (I use ones with pits as the flavor is much better and leave them whole)
- 2 tablespoons Spanish capers

- 2 tablespoons black raisins
- 2 bay leaves
- 2 sprigs fresh thyme
- 2 sprigs fresh oregano
- ¼ cup pickled jalapeño chili slices
- ¼ cup cilantro leaves, chopped

Lightly pat the fish fillets dry with a clean paper towel & evenly season with 1 teaspoon of the salt. Place the fillets in a glass baking dish & top with the lime juice. Refrigerate for 30 minutes to 1 hour.

Meanwhile, heat the olive oil in a large cast-iron skillet or Dutch oven over medium-high heat until the oil is very hot & begins to shimmer. Stir in the onion & cook for 3 to 5 minutes, or until the onion begins to soften. Add the garlic

& continue to cook for another minute. Stir in the tomatoes & cook the mixture for an additional 10 minutes, until the tomatoes begin to soften & release their juices.

Reduce the heat to medium-low & add the olives, capers, raisins, bay leaves, thyme, oregano and pickled jalapeños to the pan. Season with the remaining 1 teaspoon salt and cook for an additional 15 minutes.

Remove the fish from the marinade & gently nestle on top of the sauce. Cover the pan with a tight fitting lid or double layer of aluminum foil & cook for 4 minutes. Gently turn the fish over & cook for an additional 4 minutes, or until the fish is opaque & begins to flake. Remove the bay leaves, oregano and thyme sprigs. Sprinkle with chopped cilantro, taste and season with additional salt (if desired) and serve. (Please let [Susan](#) know if you have a recipe you'd like to share.)

Privacy, View, & Lighting—Trees

One thing we all covet is our privacy, view, & lighting policy. Whenever you make any alterations to your property it needs to be approved by the architectural committee for that very reason. With the drought and the bark beetle infestation we have lost a number of large trees.

We want to remind you of Rule 5.03 d. Cutting Trees. No trees over four inches in diameter at a point 4 feet above the base are to be cut on native ground without prior approval of the Board. A request to remove trees should be included on the application with photographs of existing trees.

If you severely trim or remove any trees without permission and affect your neighbors privacy you may be required to plant new mature trees to rectify the situation.

It is always better to ask for permission rather than forgiveness!

What is Going On in Our Canyons?

In short, your Board has focused a lot of attention and money on the homeless issue in our canyons. Results have been less than perfect.

David Wiles, your Security & Safety Chairperson, located two small “cabins.” These have been disassembled with the cooperation of the tenants. Both had four walls and a roof. One had a locked front door and a solar panel. Additional trash has been removed from multiple sites and the occupants evicted. Weekly random patrols by our uniformed agents continue.

On the other hand, several new individuals have been noticed and a burglary occurred on Norris Rd. The police were called and an arrest was made.

What Can You Do to Help?

If your home is located on a canyon, walk out to your back yard and take a look. If you see an easy access route into and out of the canyon, make changes. Making access to your property from the canyon difficult improves your security. Also, installing motion detector lights is a good deterrent. Homeowners need to be diligent & proactive by calling the SD Police if they see signs of activity in their canyon.

Our hope is that this issue can be fully resolved before next years fire season.

Street Safety & Front Gate



Please remember, speeding (over 25mph) in Alvarado Estates is against the rules, and is a rude way to treat your neighbors. We have no sidewalks and with lots of walkers - **and now with more children going to the Tot Lot, pets to the Dog Park & golfers to the Pitch n' Putt** - just please slow down.

Street Cleaning - The street sweeper is in Alvarado Estates on the third Wednesday of every month, between 9 am and noon. **Please have cars parked in driveways and bushes/trees close to the street trimmed so the sweeper has the 10 feet of height he needs to get close to curbs.** Also, please help by sweeping up and keeping your curb areas clear of debris.

Blowing Leaves By Gardeners - OUR HOA IS NOW RESPONSIBLE FOR THE STORM DRAINS BEING CLEANED OUT & MAINTAINED. WHICH MEANS WE ALL PAY! Please inform your gardeners to blow leaves into a pile and sweep up the leaves and place them in

the trash cans. We have observed them blowing leaves into the neighbors yards, as well as, blowing them into the storm drains. **Be a Good Neighbor and pick up your leaves.**

Fire Season & Defensible Space - Now is the time to clear your canyons and within a 100-foot radius from any structure of any combustible vegetation (dry grass, brush, weeds, litter and waste). Do not completely remove all vegetation which would leave the ground bare. Some vegetation is necessary to prevent erosion. Do not remove or disturb the existing plant root system. Trim trees that overhang or touch structures.
